## Primary Agenda Items:

1. Welcome to new Board members: Jason, Jaime, and Martin
2. VHEAP and SCHEV collaboration. Invitation for Emily Salmon to join us for an informational meeting.
  - a. Emily coming to August 18th meeting
  - b. Important to educate Emily about VHEAP and what we do
  - c. Bring a nice perspective of the educational aspect to the SCHEV Advisory Group
  - d. Possibility of joining efforts
  - e. Action/roll out concerns
  - f. Is there an effort to coordinate some initiatives, such as data requests for students and HR
  - g. How can we best coordinate membership of VHEAP? Would need to prepare membership to reign in the conversation
3. Captioning RFP Update - Lori
  - a. Likely all in place by September 1st
  - b. Two year contracts with a possibility of renewal (2 years) and subsequent renewals of 1 year.
  - c. Built-in tiered pricing to the contracts. All minutes used by all state agencies will allow for pricing to come down for all agencies.
  - d. Community colleges, private, public and K-12 can take advantage of the contracts as well.
  - e. Other states are looking at this model as well.
  - f. Advertising this opportunity is going to be one of our tasks as an organization. Virginia Information Technology Agency (VITA) would be a great way to market to the state agencies; embedded VITA folks in each agency.
